# VINCE Validation Prize 2019 – **DEADLINE EXTENDED!**

We have extended the deadline of the <u>VINCE Validation Prize 2019</u> up to Friday, 10 May 2019. Do not miss the opportunity to submit your case study!

The **VINCE Validation Prize 2019** follows the successful initiative of the OBSERVAL and OBSERVAL-Net projects (2009, 2010 and 2013) and is an award given to the most innovative and transferable initiatives in the area of the Validation of Prior Learning



(VPL) and/or Validation of Non-formal and Informal Learning (VNIL) from all sectors of education in Europe.

We are interested in receiving practices showing that validation makes a difference, especially illustrating inspiring and innovative solutions to help newcomers (with a focus on individuals with a migrant or refugee status) to get their skills and competences recognised and validated. The three best cases will win a trip to attend the final event of VINCE in Barcelona, 14 November 2019<sup>1</sup>.

# VINCE prototype course for validation professionals

Validation of non-formal and informal learning (VNIL) is a powerful tool to ensure newcomers and refugees are given the chance to access both education and the labour market in the host countries. However, not all the validation professionals have the knowledge and preparation needed to help this category of learners. One of the reason for this is that there is currently no formal training available for validation professionals.

VINCE has tried to fill this gap by designing the prototype structure of a Continuing Professional Development



Course (CPDC) addressed to validation professionals. The course is designed to enable professionals working in Higher Education (HE) to reflect on and improve their practice. It is built around the 5 main stages of the validation process - Information, Identification, Documentation, Assessment and Validation, and aims to give insights and ideas for organising staff training that aims to promote inclusive policy and practice in the validation of non-formal and informal learning in HE, especially focussed on migrants and newcomers. The document has been designed so it can be adapted to any institutional, regional or national environment with flexible timing.

The final layout of the generic course prototype is currently under revision. The course will be available on the VINCE website by the middle of May 2019.

#### VINCE consultation in Thessaloniki (GR)



On Friday, 17 May, the VINCE partners will have a face-to-face consultation in Thessaloniki (GR) with key stakeholders. The main object of the consultation will be the draft policy recommendations developed by the consortium. These will be discussed with representatives of CEDEFOP and other local/regional stakeholders, experts in VPL/VNIL issues, with the aim of taking on board their expertise and refine the content of the policy paper. Before and after this activity, the partners will gather in the 4<sup>th</sup> project meeting. Both events are being hosted by the Aristotle University of Thessaloniki.

The aim of VINCE policy recommendations is to ensure that policy makers at European, national and institutional levels, take action to ensure the effective implementation of the changes needed in order to make validation procedures more suited to address the needs of newcomers and refugees. The set of revised policy recommendations will be published in the weeks following the consultation in Thessaloniki. Keep following the <u>VINCE website</u> not to miss them!
